### Mounjaro Injection Update

The Practice has been given strict guidelines on who we can prescribe this weight loss drug to. This is based on the criteria stated below, if you do not meet this criteria, please do not ask as we will not be able to override the NHS England guidance.

For eligibility, patients need to have a BMI of 40 and over, and at least 4 out of 5 of the stated co-morbidities:

- Hypertension
- Type 2 Diabetes
- Dyslipidaemia
- Obstructive Sleep Apnoea
- Cardiovascular Disease

You must also be between the ages of 18 years - 75 years of age.

If you meet the criteria above and wish to have this prescribed you should also be aware you will be expected to attend a Healthier You: NHS Behavioural Support for Obesity Course.

Once we start prescribing you will be expected to attend the course stated above and a monthly face-to-face appointment where your weight will be checked to ensure the medication is working and the dose is adjusted accordingly.

### 25/26 Autumn/Winter Flu vaccinations

# The following cohorts are announced and authorised to be eligible to receive a flu vaccination:

### From 1 September 2025:

- pregnant women
- all children aged 2 or 3 years on 31 August 2025
- primary school aged children (from Reception to Year 6)
- secondary school aged children (from Year 7 to Year 11)
- all children in clinical risk groups aged from 6 months to less than 18 years

#### From 1 October 2025

- those aged 65 years and over
- those aged 18 years to under 65 years in clinical risk groups (as defined by the Green Book, Influenza chapter 19)
- those in long-stay residential care homes
- carers in receipt of carer's allowance, or those who are the main carer of an elderly or disabled person
- close contacts of immunocompromised individuals
- frontline workers in a social care setting without an employer led occupational health scheme including those working for a registered residential care or nursing home, registered domiciliary care providers, voluntary managed hospice providers and those that are employed by those who receive direct payments (personal budgets) or Personal Health budgets, such as Personal Assistants

### 25/26 Autumn Covid Booster Vaccinations

The Joint Committee on Vaccination and Immunisation (JCVI) has updated its <a href="advice-for-the-autumn 2025 COVID-19 vaccination programme">advice-for the autumn 2025 COVID-19 vaccination programme</a>, which has been accepted by ministers. The focus of the programme is shifting towards targeted vaccination of those at highest risk of serious disease.

### For autumn 2025, COVID-19 vaccination will be offered to:

- adults aged 75 years and over
- residents in care homes for older adults
- individuals who are immunosuppressed aged 6 months and over

If you are eligible for flu vaccination and covid vaccination we aim to co-administrate both vaccinations at the same time (subject to covid vaccine availability). If you are eligible for vaccination, please feel free to make an appointment in one of our vaccination clinics.

## Did you know the Contraceptive pill is now available directly from local Pharmacies?

Women in the North East and North Cumbria can now get the contraceptive pill directly from their local pharmacy, without needing a GP appointment.

Pharmacies can already treat simple urine infections for women, and now they can offer the contraceptive pill too – whether someone is starting it for the first time or continuing with their regular prescription.

The service is free and confidential and offers more choice about where and how to access contraception, making it quicker and more convenient while also helping GP surgeries, and sexual health clinics, by freeing up appointments for those with more complex needs.

A short check-up will still be needed once a year, which will take place at the pharmacy when the next supply is collected. If any unusual side effects occur and do not go away, it is important to speak to a pharmacist or GP straight away.

The service is available to all women, including those under 16. Personal details will only be shared with parents or carers if there are serious safety concerns.

#### **ARRS STAFF**

The additional roles reimbursement scheme (ARRS) funds a range of roles beyond traditional GPs, including clinical pharmacists, pharmacy technicians, mental health practitioners, and more. The ARRS staff are health care professionals funded by the scheme to expand the workforce in general practice and improve patient care. Patients can also <u>direct book</u> an appointment into the services without the need to see a GP. If our staff feel it appropriate for you to be referred to an ARRS they will suggest so. This will ensure you are seen within a timely manner and could save a GP appointment for something that can only be dealt with by a GP.

### **First Contract Practitioner (FCP)**

Muhammed Mubeen is a first Contact Practitioner (FCP) and is a Musculoskeletal Physiotherapist working in an extended role to assess and manage patients who contact the surgery with Musculoskeletal (MSK) conditions. Our FCP can see patients with conditions affecting bones, joints, muscles, tendons and ligaments without the need to seek advice beforehand by a GP or Nurse Practitioner.

### **Clinical Pharmacist**

Clinical Pharmacists work closely with our providers and care teams to optimise medication management, support chronic disease management and ensure safe and effective use of medications.

### **Pharmacy Technicians**

We have two Pharmacy Technicians at the Practice Amy and Angela who manage prescriptions, conduct medicines reconcilliation, conduct medicine audits, counsel patients on medicines and support structed medication reviews.

### **Care Co-ordinators**

We have two Care Co-ordinator (Michelle and Sarah) who assist with the care of our patients needing regular contact or requiring complex care. They are the named contact for patients with some life limiting conditions or some patients needing extra support in managing their own care. Michelle and Sarah are also the named contact for some patients with Learning Disabilities and some forms of Dementia or other cognitive impairment. They will liaise with clinicians on behalf of the aforementioned patients with queries relating to various aspects of their care.

### Social Prescribing Support Practitioner (SPSP)

We have Social Prescribing Support Practitioners (SPSP) linked to the Practice. Social Prescribing can provide short term support with social isolation, loneliness, emotional wellbeing, long term conditions, loss of confidence/purpose, poor health linked to housing or housing conditions, financial issues, substance/alcohol misuse, domestic abuse and support with accessing work, training or volunteering. To access the Service please ask one of our Medical Administrators for a referral.

### Mental health Support for under 18 yr olds

We have a Clinical Nurse Specialist who can offer mental health support for patients under 18 years of age.

#### What is available:

- Brief Psychosocial Assessment/Secrrening face to face (6 18 yrs only)
- Brief Intervention/Psychoeducation (6 18 yrs only)
- Support with onward referrals for short or long term support
- Signposting
- Multiagency Liaison
- Advice and Consultation
